- Collaborated with the Commonwealth
  Telecommunication Organisation (CTO) in a
  consultancy commissioned by the National
  Information Technology Authority (NITA-U) to
  conduct a Gap Analysis of the Policy, Legal and
  Regulatory Framework for Uganda's Information
  and Communication Technology (ICT) sector.
  The Consultancy was carried out as part of the
  Regional Communication Infrastructure Program
  (RCIP) under the Ministry of Information and
  Communications Technology and National
  Guidance (MoICT&NG).
- Acted as a consultant on the review of the telecommunications licensing framework.
- Advised a telecommunications company in Uganda in relation to its license renewal application and process.

The Supreme Court of Uganda confirmed the findings of all the lower courts and upheld the termination rates claimed by the Operator
- Successfully represented a local telecommunication company in a suit lodged by a licensee challenging the levying of license fees in respect of short codes issued under the Uganda National Numbering Plan Guidelines by the Uganda Communications Commission.
- Advising a satellite company, on the Ugandan laws and regulations which will impact the deployment of a constellation of Low Earth-Orbiting ("LEO") satellites which are designed to operate in the Ku-Band and Ka-Band frequencies in Uganda.
